Nonviolent Crisis Intervention (NVCi) Autism Refresher

Description:

Educators recognize the need for timely, effective nonviolent intervention with students who exhibit challenging behaviors, including students who have been identified on the autism spectrum. They know that such intervention improves the physical safety of all participants and creates a more trusting and caring learning environment.

Anyone who may have to manage verbally or physically aggressive individuals will benefit from the skills and techniques learned in Nonviolent Crisis Intervention. The content of this workshop addresses the Act 125 requirements regarding the appropriate use of seclusion and restraint. This class also addresses some of the considerations when working with students on the autism spectrum and/or other disabilities, i.e. nonverbal students). A fundamental understanding of autism spectrum disorders will benefit the participants.

Workshop Objectives:

1. Identify the potential for violent or disruptive behaviors in both verbal and nonverbal individuals
2. Reduce tensions
3. Prevent violent episodes, including self-injurious behavior
4. Intervene safely in violent situations
5. Develop safe humanistic approaches to crisis intervention
6. Improve staff confidence and boost morale
7. Provide optimum care for individuals
8. Identify the new requirements regarding the use of seclusion and restraint in Wisconsin
9. Combine an understanding of NVCi and PBIS to work more effectively with students including those on the autism spectrum.



Who should attend?

Regular and special education professionals and paraprofessionals working with students with challenging behaviors, including teachers, principals, school counselors, social workers, psychologists and other educational specialists. (This training is not recommended for parents.)

Prerequisite: Attendance at a NVCi Initial Training within the last 18 months.
