



District Administrator Performance Evaluation System Training (DAPES)

Audience for Training:

ALL District Administrators and School Board Members

(Districts using EITHER the CESA 6 Effectiveness Project[®] or WI DPI Educator Effectiveness Model)

Training Description

All DAPES Training models will engage the District Administrator/Superintendent and School Board in a process that will:

- Unite the School Board and District Administrator/Superintendent in a partnership for District Administrator evaluation and professional growth;
- Enhance the District Administrator and School Board's understanding of the research-based DAPES standards, indicators, and rubrics; as well as the concept of preponderance of evidence used to document and score the performance of the District Administrator's practice and product;
- Identify the timeline for implementation of the DAPES and the responsibilities of the District Administrator and School Board as partners in DAPES; and
- Inform the District Administrator and School Board of the ongoing support they will receive from CESA 6 in order to sustain and improve the use of DAPES.

4 Training Model Options/Costs

- **Model 1:** Full-day In-District Training (\$2800 one-time training & \$500 annual fee)
- **Model 2:** Two Half-day In-District Trainings (\$3800 one-time training & \$500 annual fee)
- **Model 3:** Full-day Regional Training (\$1800 one-time training & \$500 annual fee)
- **Model 4:** Customized Training is also available (cost to be determined)

Note: Models 1, 2, and 4: For these in-district trainings, the dates and times for training are at the discretion of the District Administrator and School Board.

Model 3: Full-day Regional Training—13 Regional Trainings, beginning in February, 2015, will be held across the 12 CESAs. Regional Trainings will be limited to 8 to 10 districts per training. Districts participating in these Regional Trainings must have the District Administrator and at least one School Board member attend the training, but districts are encouraged to have ALL School Board members participate in this training.
