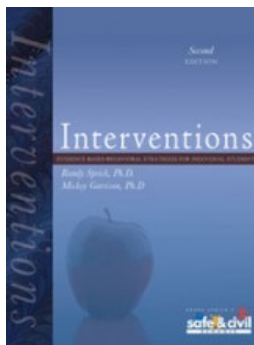

Description

This 100% on-line graduate level course is for educators who are looking for structured interventions in the classroom. These six highly structured interventions are from the book *Interventions: Evidence-Based Behavioral Strategies for Individual Students*, by Randy Sprick, PhD, founder: Safe & Civil Schools.

You have established a vision for your classroom, generated clear expectations and rules. This course is aimed at assisting teachers, counselors, paraprofessionals, and others who work with students who struggle with chronic misbehaviors, in the planning and implementing of validated, tiered strategies to increase motivation and improve behavior.
