Making Inclusion Work: Helping Case Managers Direct, Support, and Manage Paraeducator Staff

Description:

Many of your students with special-education needs require adult attention to be successful in a general education classroom. This support is often provided by a paraeducator. How can you best support your paraeducator to provide quality services to students? How do you support your regular education teachers to effectively communicate with, and provide direction to paraeducator staff? How do you make sure roles are understood by everyone on the team: paraeducators, teachers, and administrators? How can paraeducators be used to increase student independence? These questions will all be explored at this one-day training. In addition, opportunities for future collaborations about this topic will be discussed.

Objectives:

- Participants will develop a clear understanding of the need to facilitate student independence versus dependence on adults.
- Participants will develop a clear understanding of the ways in which job-specific role definitions can enhance student outcomes.
- Participants will learn multiple strategies which can be used to improve collaborative problem solving and data collection.
