Description

Is your district in a position to move beyond the Wisconsin Induction Guidelines in terms of support for Initial Educators? CESA 6 Mentor training has been designed to instruct a comprehensive framework for induction in a 21st Century Induction Model/Learning Community. The Wisconsin Quality Educator Initiative PI 34 requires that all school districts provide a comprehensive, quality support system for initial educators. The support system must include the key components of providing a qualified mentor who has been trained in the confidential formative assessment of initial educators.

Outcomes

1. Increased student learning
2. Decreased expenses related to staff turnover
3. Increased teacher effectiveness
4. Strengthened commitment to the profession for Initial Educators and mentors resulting from collegial relationships and professional growth
5. Improved building continuity related to teacher learning and retention

District and school administrators, teachers and education specialists (with a Professional Educator license) currently serving as mentors to Initial Educators and those who wish to be trained and certified as mentors.
