Description

Wisconsin school districts want to hire and retain gualified substitute teachers. Wisconsin enacted a rule allowing school districts to hire non-certified teacher substitutes. To be issued a three-year, short term substitute teacher permit, individuals must hold a (four year) Bachelor's degree. receive appropriate training, and be sponsored by a school district. Our training goal is to teach and engage prospective substitute teachers in activities that mirror real classroom situations. Our certified instructor will model a variety of teaching methods that substitute teachers can use in the classroom. Additionally, we want participants to gain a deeper understanding of effective teaching principles in order to prepare them for future substitute teaching assignments.
