Restraint and Seclusion in Public School Updates

Wisconsin passed a Seclusion and Restraint Law effective September 1, 2012. The legislation requires all Wisconsin public school employees that use physical restraint be trained in the safe use of restraint. In Wisconsin and CESA #4, the program that meets the requirements of the law is the Crisis Prevention Institute's Nonviolent Crisis Intervention Training.
