This workshop will provide participants with an overview and understanding of the core concepts of sensory processing and emotional regulation, focusing on the unique needs of students with autism spectrum disorder (ASD). Participants will be able to answer the question : What is sensory processing and how do we set up the environment and provide tools for self-regulation? Numerous tools and resources will be provided to address the sensory and emotional regulation needs of students with ASD and other social-emotional needs.

Course objectives:

- Define the various sensory systems and sensory processing differences in students with ASD.
- Identify the educational implications of sensory processing differences.
- Identify strategies/tools/methods for self-regulation.
