Ethics and Boundaries in Social Work

Description

In January 2018, an Updated NASW Code of Ethics went into effect. This presentation will share these changes and the related implications for school social work practice. Participants will consider the school social worker responsibility towards furthering equity in our schools, and ideas for including the student and family voice in decisions that affect them. Participants will apply both the Supplemental Ethical Standards and the Updated NASW Code of Ethics to real-life ethical challenges experienced by school social workers.



Workshop objectives

- Consider how school social workers live out the values in the NASW Code of Ethics in their daily work.
- Further understanding of the Updated NASW Code of Ethics and its implications for School Social Work Practice.
- Further understanding of the DPI's focus on equity and consider our ethical responsibility to include the student voice in decisions that affect them.
- Consider the implications of ethical violations through a review of violations in Wisconsin.
- Become familiar with one ethical decision-making model and engage this model in practice.
- Apply the Code of Ethics and Supplemental Standards to practice scenarios.

Upon completion, participants will earn 4 CEHs for ethics and boundaries training, as approved by NASW-WI.
