



Reading Academy: Evidence-Based Practices in Instruction and Intervention

(Aligned with WI SLD Rule Changes)

August 21-23, 2013 • Nov 12, 2013; Feb 25, April 29, 2014 • 8:30 am - 3:30 pm

Description:

This "Research to Practice" academy is intended to support educators who want to extend and expand their capacity to provide effective instruction for reading at the Elementary and Middle School levels. The main focus is to provide teachers information and support that they need to produce exceptional learning outcomes for all students. The information provided will be tailored to maximize alignment with Common Core Standards, College and Career Readiness targets and will support Multi-Tiered Systems of Support / RtI initiatives. The academy consists of three parts:

1. Three-day summer academy will provide an overview of the research on reading development, introduce essential instructional practices that are evidence-based and align with the CCSS, and outline specific intervention strategies that are evidence-based.
2. Identify some commercially available interventions that meet the criteria of evidence-based in the Wisconsin SLD rule and work with publishers to offer trainings on specific programs for the districts interested in purchasing them, with the intent of reducing costs by consolidating trainings.
3. Three follow-up sessions during the school year to support educators in implementing essential instructional practices and interventions with fidelity and developing a plan for implementing and evaluating multi-leveled systems of support within their districts.

Workshop Objectives:

- Review and understand the research on evidence-based reading instruction and its relevance for instructional decision-making.
- Learn and practice essential instructional practices in reading instruction and intervention.
- Provide a "toolkit" of evidence-based strategies that align with the CCSS and WI SLD Rule.
- Provide follow-up support and networking opportunities to ensure that evidence-based instruction and interventions are being implemented with fidelity.
- Review commercially available instruction/intervention programs that meet the standards of evidence-based and learn about available training and support.

Who should attend?

Building-level teams of 3 to 5 educators. Teams may include regular, ELL, and special education teachers, individuals who will be considered "interventionists" and "data analysts" under the new SLD rule. An **administrator is strongly encouraged** to attend.
