# PBIS Administrative Overview Tier 2/Tier 3 AA696

May 6, 2014

### Description

- This full day training provides an administrative overview of the system structures and commitments needed for effective implementation of Advanced Tiers of school-wide PBIS. This includes a description of the Tier 2 and 3 systems, data and practices that are required for successful implementation. Emphasis is on the continuum of support across a three-tiered system, highlighting administrative support from building and district administrators so that allocation of resources enables fidelity of implementation.



### Workshop Objectives

- District and school-level leaders need to have a complete understanding of what the PBIS Tier 2/3 systems, data and practices entail so they can provide the necessary guidance to school staff as they move through Tier 2 and Tier 3 training and implementation. Repositioning of personnel to coach and facilitate specific PBIS Tier 2 and Tier 3 components become necessary at these levels. Administrators must be aware of needed roles/functions for Tier 2/3 implementation so they can anticipate and plan accordingly.

### Who should attend?

- District/school administrators including special education leaders, principals, internal/external PBIS coaches/specialized services personnel, such as social workers and school psychologists. Those attending must have attended Tier 1 training. Have 70% BoQ, 80% on TIC, 80% on SAS or 80/80 on SET.
