December 9, 2013: Response to Intervention FAQ's

John Humphries, Johanna Chenous, and Tiffany Helmke will lead a discussion about implementation of the Wisconsin SLD rule and using RtI to make decisions about special education eligibility. They will share the nuts and bolts of implementation from the perspectives of both director of pupil services and school psychologists.

Presenters: John Humphries is a school psychologist and director of pupil services in the Dodgeville School District. He was the DPI consultant for school psychology for seven years and was co-author of PI 11.36(6). Johanna Chenous and Tiffany Helmke are school psychologists in the Dodgeville School District.

February 10, 2014: Essential Statistics and Measurement Knowledge in the Age of **Rtl Implementation, Student Learning Objectives and School Report Cards**

Dr. Dan Hyson will delve further into the stats and measurement skills necessary for RtI implementation, including the ability to evaluate the psychometrics of screening and progress monitoring tools and to identify and evaluate research-based interventions, including using rate of progress to evaluate intervention effectiveness. That foundational knowledge will also build capacity for school psychologists to assist in writing SLO's and interpreting school report cards. (Network participants may identify ongoing questions on December 9th to guide Dr. Hyson's presentation.)

Presenter: As the Data Management Coordinator for the Hiawatha Valley Education District in Winona, MN, Dr. Dan Hyson manages an online data warehouse and consults with individuals and teams to help them access, interpret and use student performance data to drive instruction and set school improvement goals.
