## Description

In 2013, the WI Department of Public Instruction published new standards for all CTE program areas. Understanding and implementing these standards is important in building even stronger CTE programs.



## Workshop Objectives

- Understand how the new standards are connected to the Literacy and Mathematics Common Core Standards
- Develop a course map for at least one of their courses
- Develop Essential Questions for the course that will lead students to deeper understanding in that course
- Learn a process to create Unit Plans and Lesson Plans for a course so that the course is standards-based
- Begin to consider assessments that will measure standards targets for the course.
