Description:

LLI is a small group intervention for children in Kindergarten and Grades 1 and 2, who find reading and writing difficult to learn. Reading Recovery ® is recommended for the lowest first grade students, and other low students may be serviced through Leveled Literacy Intervention ® in groups of three. In Kindergarten and Grade 2, the children selected for the interventions are the lowest achievers in literacy in their grade level and are not receiving another intervention.
