Description:

LLI is a small group intervention for children in Kindergarten and Grades 1 and 2, who find reading and writing difficult to learn. Reading Recovery® is recommended for the lowest first grade students, and other low students may be serviced through Leveled Literacy Intervention® in groups of three. In Kindergarten and Grade 2, the children selected for the interventions are the lowest achievers in literacy in their grade level and are not receiving another intervention.

Workshop Objectives:

- Understand the change in fluency overtime
- The role of fast processing
- Implementing the six dimensions of fluency
- Teaching for fluency

Leveled Literacy Intervention Features:

- Fast-paced lessons that include explicit instruction in phonemics/phonics, vocabulary, fluency, and comprehension
- Daily lesson guides with prescribed sequences of texts
- Instructional interactions between teachers and students with a 3:1 student-teacher ratio
- Emphasis on comprehension of fiction and non fiction texts with time engaged in reading continuous texts
- Continuum of student understandings to guide the series of lessons

Who should attend: For first year LLI teachers of Grades K-2 whose students are struggling with reading and writing, previously trained LLI teachers, reading teachers and Tier 1 Classroom teachers who teach guided reading.
