Description:

Leveled Literacy Intervention Red and Gold systems are specifically written and designed to address the interests and needs of students in grades 3 and 4 who are falling below grade-level expectations in reading. Lessons provide students with opportunities to read a variety of genres while working on comprehension, vocabulary, fluency, and writing about reading.

Workshop Objectives:

- Observe, code, analyze, and interpret reading behaviors
- Defining what effective readers do and understanding what struggling readers find difficult
- Using appropriate prompts in helping readers
- Student Progress Monitoring

Leveled Literacy Intervention Features:

- Fast-paced lessons that include explicit instruction in phonemics/phonics, vocabulary, fluency, and comprehension
- Daily lesson guides with prescribed sequences of texts
- Instructional interactions between teachers and students with a 3:1 studentteacher ratio
- Emphasis on comprehension of fiction and non fiction texts with time engaged in reading continuous texts
- Continuum of student understandings to guide the series of lessons

Who should attend:

For first year LLI teachers of Grades 3-6 whose students are struggling with reading and writing, previously trained LLI teachers, reading teachers and Tier 1 Classroom teachers who teach guided reading.
