## **MyLearningPlanOASYS**

This session will focus on the “behind the scenes” syncing process in MLPOASYS that results in data flowing to the end of year summary document. Participants will see an example of an end of year summary document and engage in conversation their local MLPOASYS data flow process. Additionally, the session will introduce participants to various system reports. The SLO/PPG/Evidence Sources report will be highlighted. Finally, the session will include a review of the Evidence Collection Tool for Observations and the value of the “Admin View”.

## **Implementing EP Through a Systems Lens**
