MyLearningPlan OASYS

This session will focus on IMPORTANT MLP must knows for 2014-15 including:

- Doc log & data integration
- Assigning forms to an evaluator
- Process view verification of users and evaluation types
- Checking on districts buildings and building level approvers
- Checking on executive support and technical support personnel for each district
- Ensuring evaluators are not assigned to their own evaluation or assigned other administrators evaluations they are not responsible for conducting.

The session will conclude with an Open Café for questions and sharing among districts.

Student Outcome Summary Components & SAPES

We will explore the meaning of each Student Outcome Summary score component, including SLOs, reading value added and graduation rates for both educators and school administrators. Clarification will be provided regarding data that is submitted to the U. S. Department of Education and what this means at the state and local district levels. Finally, we will review a checklist and timeline to help guide the principal as the evaluatee and Superintendent as the evaluator.

MyLearningPlan: Professional Development Management System (PDMS)

MyLearningPlan PDMS, the leading K-12 Professional Development Management System in the US, is a web-based tool that helps school districts manage all aspects of in-district and out-of-district professional learning in one comprehensive online system. CESA districts using MLPOASYS will be able to tie the evaluation process back to professional learning by enabling the Learning Loop. With the Learning Loop, administrators are able to recommend PD based through an automated process that derives the teacher's needs based on the individual's evaluation results. State-specific teaching standards are used to align evaluation criteria with the professional learning offerings. This feature allows leaders to ensure that educators have opportunities to engage in professional learning experiences that relate directly to their identified needs in support of our goal of having a staff full of effective teachers!
