He presented at seminars and distributed the toolkit to over 3,000 people in health care, law enforcement, and education fields in the Midwest and New England states. This program was one of nine that was highlighted at the 2011 SAMHSA Service to Science Academy.

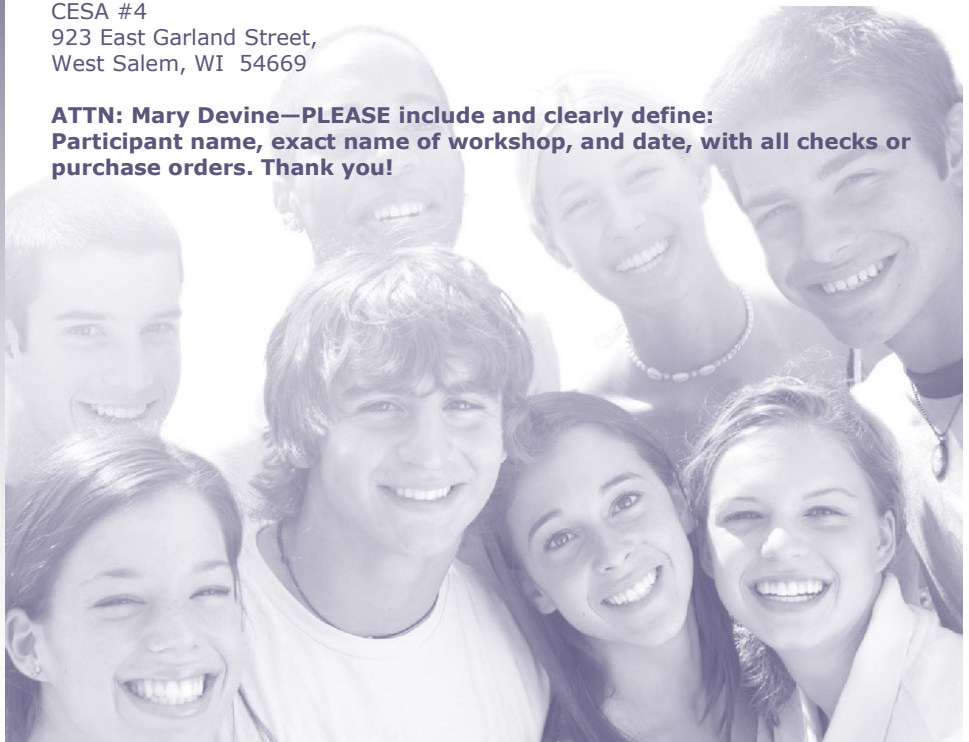
