

# Statewide Title I Network Benefits



The Title I Network is a collaborative effort with the Co-operative Educational Service Agencies (CESAs) that provides increased technical assistance and professional development for districts and schools with Title I programs. With financial support from the Department of Public Instruction (DPI), each CESA provides free/reduced cost Title I services for all school districts in their CESA. in the following five areas:

## Title I Application

Consultation with Title I coordinators regarding Title I law, programming, reporting requirements, and monitoring.

## Title I Coordinator Leadership

Information and resources for Title I coordinators through one-on-one technical assistance, at least two regional meetings, and a Title I coordinator orientation.

## Districts/Schools ID'd for Improvement

Assistance to Title I districts and schools identified for improvement including identifying and implementing improvement strategies and sanctions as required under No Child Left Behind (NCLB).

## Professional Development

Access to multiple professional development opportunities based on regional Title I needs that have been identified by districts in each CESA.

## Resources and Collaboration

Information and resources regarding local and statewide initiatives and agencies that can provide Title I related support.

Current opportunities exist in adolescent literacy and math. Enrich your curriculum and your teachers' expertise as they explore new, innovative ways to improve student learning.

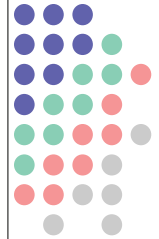
## Preferential Pricing for CESA 5 Workshops

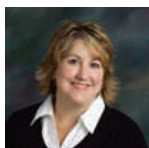

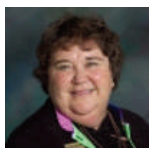
# CESA 5 Schedule of Title I Services & ESEA Events (2010-2011)
