- The Speaking test component
- The Kindergarten test component

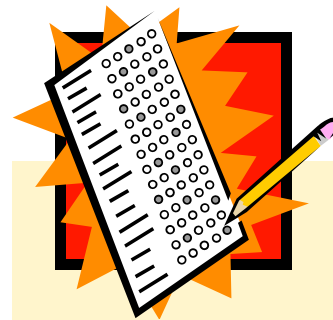
