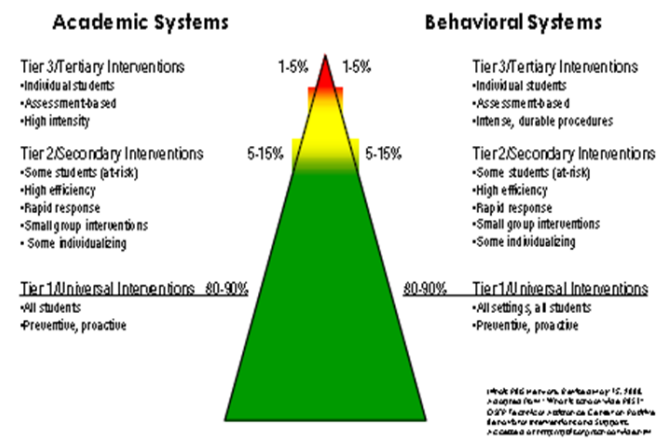
Presenter: Gary Mulry is in his 30th year in the field of education. Gary has been a regular and special educator as well as elementary principal. He is currently the Positive Behavior Support Specialist for Appleton overseeing the entire PBIS process in addition to overseeing EBD elementary programming for the district. The AASD has eighteen schools implementing PBIS this school year. Gary is a Universal PBIS Trainer for the state of Wisconsin and teaches graduate classes at Viterbo University. Gary's enthusiasm for PBIS is contagious!

Description: Coaches/Principals: Having attended a PBIS Overview session, this one day workshop is specifically designed for a building principal and the identified internal and external coach of school teams beginning the Tier I training of PBIS. This day focuses on preparing Coaches and Administrators for the various activities and steps their teams will take in moving to PBIS implementation. Those who attend this training must return with their school teams in order to complete the Tier I training process (2 additional days).

Team Training: The designated PBIS School TEAM (including administrator and coaches) participate in TWO days of intensive, interactive training in order to prepare the implementation of PBIS in your school. This training is geared for high schools in order to meet the unique needs of secondary students and teachers. Bring any school based behavioral data as well as your current office discipline referral form. **A half day in September, 2011 will be held for team members to evaluate the kickoff.**

Note: Attendance at a PBIS Overview session is required prior to the start of Universal Team Training. This can be done by teams or by administrators. The Team Readiness Checklist must be completed and reviewed by Michelle Polzin, Wisconsin PBIS Center Coordinator, prior to training.

Cost for All Level Coaches Training on February 7th is \$175.00 per person includes one day of training, materials, continental breakfast, and lunch.
