4. Develop and record an action plan applying the new information from the daily topic.



It is suggested that a school based leadership team should be brought to all three events. The leadership team should consist of the building administrator, special education teacher, reading or math specialist, general education teachers, curriculum and assessment coordinator, and any other staff you feel would be integral in implementing this change.
