## Description:

Participants in this hands-on course will examine the new learning environment for teachers and students made possible through the effective use of Google Tools. This course will focus on many free applications from Google that support teaching and learning. Some of the Google applications that will be introduced are: Google Docs, Spreadsheets, and Presentations, Google Calendar, Google Advanced and Specialized Search, Google Customized Search, Google Maps, Google Books, Picasa, and Blogger.

Participants will discuss best practice examples and methodologies for assessing the impact of these tools on instruction. They will also identify and discuss ways that Google Tools can be effectively used in their classrooms. Participants will use their new knowledge to develop a lesson plan or project incorporating Google Tools into their classroom curriculum or for professional development activities. This lesson plan/project will include a plan for both formative and summative assessments.

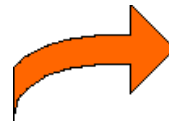
