## **Title IX-PM Session-12:00-3:00 (registration at 11:45)**

Mary Gerbig from Davis & Kuelthau, s.c. will present on the expanding law related to Title IX and gender nonconforming students. All schools are facing issues related to balancing privacy rights while ensuring access to educational programs and activities. This training session will focus on the guidance from the Office for Civil Rights regarding Title IX obligations for LGBTQ students, the state pupil nondiscrimination law and policy considerations to ensure access to educational programs for all students.
