Description

This workshop will provide participants with an evidence-based practice approach for designing and implementing appropriate educational programs for students with ASD. This approach allows for the implementation of a variety of instructional strategies. Numerous examples of how to organize various educational environments to increase comprehension and independent functioning for the student with ASD will be given. In addition, numerous easy to make visual instructional support strategies will be shown.

Workshop objectives

- Develop an understanding of the unique features and characteristics associated with ASD.
- Learn DPI educational eligibility criteria for identifying a child with an autism spectrum disorder.
- Explore unique learning/thinking/processing differences associated with autism spectrum disorders.
- Review sensory, communication, cognitive and social differences in relation to appropriate accommodations/modifications to increase the child's understanding and functional/meaningful independence.
- Increase awareness of the educational implications for students on the spectrum.
- Develop an understanding of an evidence-based practice approach for designing an appropriate educational program for students with ASD.
- Learn how to effectively organize various educational environments to increase comprehension and independent functioning for students with ASD.
- Learn how to use various visual instructional strategies to address the features and characteristics of ASD.
