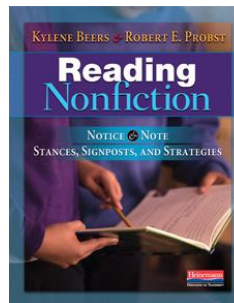
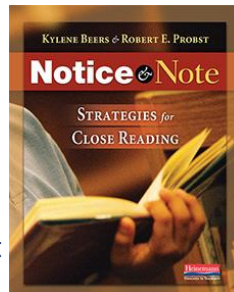
# Notice & Note In Fiction and Nonfiction (Grades 6<sup>th</sup> – 12<sup>th</sup>)

## Description

This workshop will take a deep dive into the work of Kyrene Beers and Robert Probst's texts, Notice & Note Strategies for Close Reading and Reading Nonfiction-Notice & Note Stances, Signposts and Strategies. Participants will examine the six signposts that help readers notice significant moments in both fiction and nonfiction texts. Additionally, we will examine text-dependent questions, rigor and text complexity. Multiple examples and strategies will be shared. Teachers will leave this session equipped with ideas for immediate implementation of signposts into their instruction.



## Workshop objectives

*Teachers will:*

1. Understand the connection between the strategies presented and the Common Core State Standards.
2. Examine the research behind the strategies and why they work.
3. Have a process for implementation into their curriculum.
