## November 3: Building a Multi-Tiered System of Supports

This joint presentation by a director of special education and school psychologist will take participants through the process one Wisconsin school district used to build a multi-tiered system of supports. Participants will learn how this district chose intensive interventions, how Title I and tier 2 and 3 supports evolved, and how special education referrals and services have changed as a result.

**Presenters:** Scott Moline is the school psychologist and Jason Windsor is the Director of Special Education and Pupil Services for the Westby Area School District.

## December 6: Updated Guidance on Section 504

Participants will review the legal basis and “big ideas” underlying 504 plans as well as the practical considerations for determining eligibility and developing written plans. Additional discussion topics will include Title II obligations and the recent OCR guidance regarding ADHD. Participants are encouraged to submit questions ahead of time.

**Presenter:** Mary Gerbig is an attorney with Davis and Kuelthau. She has represented school districts in numerous special education and discrimination hearings and mediations under IDEA and Section 504.

## March 10: Wisconsin School Mental Health Framework

This session will describe the multi-level Wisconsin School Mental Health Framework and the work the Department of Public Instruction is doing to share new professional development and resources available to help schools better support students’ mental health, including students impacted by trauma.

**Presenter:** Kathryn Bush is the WI DPI School Psychology Consultant, Elizabeth Cook is the WI DPI School Mental Health Consultant, and Jackie Schoening is the Wisconsin Safe & Healthy Schools Coordinator for CESA 2, 3, and 6.

## April 20: Short-Term Counseling Strategies in the School Setting

Dr. Sarah Arnold will continue her conversations with the school psychologists in our region around mental health issues and supports in the schools. This presentation will include short-term Cognitive Behavioral Therapy (CBT) strategies that can be implemented in the school setting. Those who participated in this session in 2012 will find a review of some information, but also a renewed emphasis on the most challenging behaviors as well as additional information on low-incidence disorders.

**Presenter:** Sarah Arnold, PsyD, is a psychologist with Doll and Associates, a service of Agnesian Healthcare, Fond du Lac. She is also the behavioral health consultant for the EC and 4K programs in the Fond du Lac School District.
