This program serves educators from both the public and parochial schools across southwestern Wisconsin. These activities are developed through and approved by an advisory committee made up of representatives from CESA 3, WEAC #6, Viterbo University, UW-Platteville, and our local school districts.

Program Statement

The CESA 3 License Renewal Support Center (LRSC) serves southwestern Wisconsin educators with license renewal services and support to beginning educators. The Center helps to facilitate the PI-34 process of license renewal for teachers, pupil service staff, and administrators through supporting them in the development and approval process of their Professional Development Plan (PDP).

This CESA 3 program is designed to help school districts meet their support requirements for initial educators under PI-34. Wisconsin school districts are required to provide collaboratively developed, ongoing orientation and support seminars and qualified mentors for all initial educators within their districts. In addition, districts must provide administrative support to initial educators in putting together their PDP Review Team.

This program provides specific training for mentor educators and training for veteran professional-level educators who wish to serve as members of an educator's PDP Review Team. Through support seminars and specific PDP Writing Sessions, both initial and professional-level educators can receive support in developing, writing, and completing their Professional Development Plan (PDP).

Veteran Educator Roles

Mentoring is defined as a sustained relationship between an initial educator and a trained, experienced, and qualified veteran educator. The mentor provides assistance, support, and guidance that helps the initial educator develop the necessary skills to become successful in his/her role in education. In Wisconsin, a mentor must be a colleague who is trained to provide support and assistance to the initial educator and who is NOT part of the new educator's formal evaluation process. This mentor training will equip attendees to serve as mentors for their local districts and be a part of our CESA 3 mentor cadre.

PDP Reviewer Training for New Reviewers

Dates for these trainings will be regularly scheduled throughout the school year as soon as DPI finalizes any new guidelines regarding teacher licensure.
