Presenters

Susan Barrett from Sheppard Pratt Health Systems in Maryland will deliver the keynote address. She will also lead select breakout sessions. Susan is a National PBIS Center partner and the state director for Maryland's PBIS initiative.

Also joining this year's conference is Lucille Eber. Lucille is a National PBIS Center partner and the director of the Illinois PBIS Network. Steve Romano and Marla Dewhirst, technical assistance directors from the Illinois PBIS Network, will also be leading sessions.

Susan Barrett is the director of the PBIS Regional Training and Technical Assistance Center at Sheppard Pratt Health System. She has a master's degree in counseling psychology and certification in special education. Susan works with the University of Oregon PBIS Technical Assistance Center as a resource partner. She assists with large scale implementation of SW-PBS by providing training and technical assistance in Maryland, South Carolina, Washington DC, Virginia, Vermont, New Mexico and Tennessee. She also works with Johns Hopkins University to evaluate the impact of PBIS on students, school staff and school communities.

More recently, Susan oversees the training and technical assistance portion of the Maryland Safe and Supportive Schools grant (MDS3). Within the 3-tiered logic of PBIS, MDS3 will provide high schools with technical assistance to support the identification, intervention, and progress monitoring of students in need of additional support. Trained climate specialists will support high school personnel to target the needs of high schools through the systematic selection, implementation and monitoring of selected evidence based practices that address substance use, student engagement (truancy), school violence and bullying.

Team meeting foundations are essential no matter what type of meeting is being conducted. Teams need to know the purpose and expected outcomes of their group, to establish operating agreements, and to establish roles and the expected responsibilities. This session will introduce the Team Initiated Problem Solving (TIPS) approach using discipline referral data.

Strand: Special Topics Julie Betchkal, Rachel Saladis Are you wondering how to implement PBIS in your preschoolage programs? Then this is the session for you. In 2009 Wisconsin was awarded a training and technical assistance grant from the Center on the Social Emotional Foundations of Early Learning (CSEFEL). Since then, a multiagency state leadership team has been working to build infrastructure that supports birth-to-five systems in implementing the Pyramid Model — a framework of tiered intervention to promote social and emotional competence.

This session will address how program-wide implementation of the Pyramid Model is parallel to school-wide implementation of PBIS. Content will address how program-wide and school-wide implementation are similar and how they are unique. Members of Wisconsin's Pyramid Model demonstration and pilot sites will share their experiences and lessons learned from their first year of implementation.

Tools and Resources to Support Best Practices in Classroom Management

A well organized classroom provides students with a proactive and predictable environment necessary for behavioral control and quality learning to take place. It will also suggest methods of coaching the skill sets.

High School Classroom Management

One of the primary challenges in high schools is securing staff implementation of PBIS practices. It is most meaningful when teachers can use these strategies in their classrooms and have an impact on classroom instruction. This session will provide examples for teachers to bring these practices to their classrooms in a practical manner.

Session: E2

Evidence-Based Behavioral Health Screening Tools in the **Public Domain**

Strand: Evaluation Nic Dibble, John Humphries This presentation will describe seven brief screening tools appropriate for children and adolescents that are available at no cost and can be used by pupil services professionals. Areas screened by these tools include both internalizing and externalizing disorders, alcohol and other drug use, attention, peer relationships, and criminal behavior. Guidelines for use of screening tools and strategies for improving referral success following screening will be shared.
