Training of Trainer Participant Requirements

- Participants should have prior experience in training adults and be knowledgeable in adult learning principles.
- Participants should have experience (at least 3-5 years min) in working directly with families.
- Participants should have time available within their job responsibilities to prepare for and implement the training effectively following completion of the Training of Trainers. (*Note – Direct Staff Training is a total of approx 54 hrs or 9 days*).
- It's HIGHLY RECOMMENDED that the T participants have previously participated in the Family Service Credential Direct Provider Training. Individual exceptions are made depending on a participant's prior experience.
