

Substitute Teacher **Training**

Description of workshop: Teaching is a complex, important task that requires constant growth and development. Steps to obtaining your DPI certified three-year Substitute Permit which allows you to sub in all public and private schools in Wisconsin

It is a good idea prior to taking this substitute teacher class to contact a school district that will sponsor you, meaning they do not have enough certified teachers as subs and will use you as a sub, once you receive your Substitute Permit.
