WIDA-ACCESS Placement Test™

W-APT stands for the WIDA-ACCESS Placement Test™. This assessment tool, known as the "screener", is used by educators for:

1. Placing new ELL students in the appropriate tier (within a grade cluster) of the ACCESS for ELLs™ test.
2. Providing a screener for determining appropriate placement of new students for ELL services. (Schools must screen new ELLs within 30 days of enrollment.)
3. Determining the ELP level for WKCE decision making.

In this overview, participants will receive a binder with the downloaded testing documents for using W-APT™ at their school. We will review the W-APT™ testing manual and practice administering and grading student exams at various grade levels.
