WHO SHOULD ATTEND?

The Asbestos Refresher course is designed for people who encounter and/or disturb asbestos while conducting maintenance-related activities during the course of their work. The purpose of this training is to ensure compliance with state and federal regulations. The following topics will be covered during the training session:

- The background of asbestos
- Health effects
- Personal protective equipment
- Recognizing deteriorated asbestos

This mandatory training is required to meet the OSHA asbestos regulations adopted by Wisconsin Department of Safety and Professional Services. If you or your staff

perform operations and maintenance activities at your facility, then this training must be taken on an annual basis.

This course is a refresher of the two-day initial course, which satisfies the OSHA training requirement for people who perform Class III asbestos activities.
