Workshop Description:

Despite the federal mandate that all children be considered for AT (services and/or devices) as part of their IEP, many districts lack the knowledge to accurately determine if their students could benefit from AT. Based on the work of the Wisconsin Assistive Technology initiative (WATI), this full day workshop will familiarize you with the process of Assessing Student's Needs for Assistive Technology (ASNAT). Revised in 2009 and used both nationally and internationally, the ASNAT is a process that takes the IEP team from consideration, to assessment to trials and implementation.

Addressing the issues of documentation, funding and trials, as well as exploring the areas that are supported by AT (seating, positioning and mobility; communication; reading; writing; math; organization; recreation and leisure; activities of daily living; blind/low vision; deaf and hard of hearing; multiple challenges) this workshop will bring you up to date on assistive technology (low to high tech) that can help your students function more independently. Using research based techniques and best practice in the area of AT, you can start to feel more comfortable with the use of AT with your students.
