



Becoming Swift at SWIS

Audience: School buildings implementing PBIS with teams of 3-4, Principals, PBIS Coach, Secretary-data in put person

Description: The School-Wide Information System (SWIS) is a web-based information system designed to be an efficient, reliable and confidential strategy for collecting, summarizing and using student discipline data. Research indicates that school personnel make more effective and efficient decisions when they have the “right data” in the “right form” at the “right time.” SWIS is designed to provide school personnel with the information they need to be more successful decision-makers.

SWIS was developed at the University of Oregon in the mid 1990s, is upgraded annually, and runs on dedicated servers that meet all confidentiality and reliability criteria established by federal, state and university regulations. The information system can be used for:

- Internal decision making as schools improve their discipline practices.
- Support plan design with individual students and their families.
- Reporting to district, state and federal agencies about school outcomes.

SWIS provides information at three levels: (a) the whole school, (b) targeted groups of at-risk students, and (c) intensive individualized student interventions. The three SWIS applications: SWIS, CICO-SWIS and soon to be released ISIS-SWIS align with a Response to Intervention (RtI) framework, and provide the needed data for both universal screening and progress monitoring.

- **Training will be provided at no cost as an extension to those building teams who previously** attended the PBIS Coaches, Universal Day 2/3, and Implementation day **from CESA 6 in winter/fall of 2012.** (There is an additional cost for the annual SWIS license fee of \$250.00 per building)

- **Registration fee includes:** Readiness Checklist, license application and submission, 3 hour training, year of technical support and *Swift at SWIS* user’s manual, and snacks. **(Please bring 1 laptop per building member)**
