Description: Coaches/Principals Training: Having attended a PBIS Overview session, this one day training is specifically designed for a K-12 building principal and the identified internal and external coach of school teams beginning the Tier I training of PBIS. This day focuses on preparing coaches and administrators for the various activities and steps their teams will take in moving to PBIS implementation. Those who attend this training must return with their school teams in order to complete the Tier I training process.

Description: Universal Team Training Day 1 & 2: The designated PBIS School TEAM (including administrator and coaches) participate in two days of intensive, interactive training, in order to prepare for the implementation of PBIS in your school. This training is geared for K-12 levels in order to meet the unique needs of students and teachers. Bring any school based behavioral data, as well as, your current office discipline referral form. A full day Implementation in September, 2012 will be held for team members to evaluate the kickoff.

Description: U300 Implementation in Your School: Teams will Network and share successes, initial data, and ideas from their individual kick-offs. Team work will be provided for teams to work on specific areas they choose with support, resources, and guidance from PBIS trainer and CESA 6 staff.

Description: SWISS Training: This half day session will provide web-based information system designed to be an efficient, reliable, and confidential strategy for collecting, summarizing, and using student discipline data. This training also provides a year of technical support and SWIS User's manual. **Additional cost** is \$250.00 for the SWIS annual license per building from University of Oregon.

Audience: Building level teams including an administrator, external and internal coaches, teacher leaders from a variety of grade levels and subject areas, special education educator(s), social worker, school psychologist, paraprofessional, and parents—ideally a group of 6-8 individuals from a building representing these groups.

Presenters: Gary Mulry has 31 years in education and is currently in his third year as the Positive Behavior Support Specialist for Appleton overseeing the PBIS effort. He is also one of their PBIS External Coaches for 20 schools and 6 charter schools, as well as, providing EBD program support for the elementary and middle school level programs, and teaches graduate classes. Gary is also a Wisconsin Universal PBIS trainer.

Jackie Schoening MSSW, CSSW, Certified SWIS trainer. She is the Safe and Healthy Schools and Communities Programs Coordinator for CESA 6. Jackie has 25 years experience in creating a culture conducive to teaching and learning; safe, respectful and healthy schools. She is certified in a number of research based programs that help schools address the whole child.

Cost: This five day training is bundled at a cost effective rate of \$2200.00 per building team up to 7 over that number \$300.00 per person. Breakfast, lunch, materials provided for the first 4 days. Snacks only and materials provided for SWIS training. More information will be e mailed to you prior to date. Register separately for dates wanted.

Cancellation Policy: Any workshop registration cancellations must be received 48 hours before the workshop scheduled date, for a refund to be issued. Because attendance at most workshops has to be limited, persons registering for a workshop and not in attendance on the day of the workshop will be charged the full registration fee.
