**Content:** To provide an introduction to the concepts and systems of functional assessment and behavior intervention planning to support individual students' behavior. This session will focus on simple functional assessment tools, brief intervention planning, and progress-monitoring of plans.

**Objectives:**

1. Identify the steps for conducting function-based behavioral assessments
2. Write one behavioral pathway (setting events, antecedents, behavior, consequences)
3. Create one effective Behavioral Intervention Plan (BIP)
4. Learn how to use data for decision making and on-going progress monitoring
5. Develop a system for how and when FBA/BIP's will be conducted
6. Action Plan: Develop a function-based behavioral intervention plan for an individual student using the competing behavior pathway

**Teams should bring:**

- Tier II/Secondary/Tier II/Tertiary Tracking Tool (completed for simple Tier II/Secondary level)
- Tier II/Universal & tier II/Secondary data for 1-3 students who seem toned more than simple Tier II/Secondary interventions (behavior data: OSS, ISS, time-outs, attendance, Daily Progress Report data; SWIS graphs: time of day, location, type of behavior, consequence; academic data: grades, DIBELs, etc)
- Current district/building FBA/BIP forms/tools including those from current Tier II/Secondary team/s (observation forms, teacher referral forms, etc)
- Plans/policies for simple Tier II/Secondary level supports (Tier II/Tier III Guidance Tool where completed, SAT, Targeted Teams, etc)
- Recommended resource: *Building Positive Behavior Support Systems in Schools-Functional Behavioral Assessment* by Crone, Horner

**Credit:** Two college credits through UW Oshkosh for an additional fee of \$400.00 per participant for four days

**Cost:** \$2200.00 for a team of 7 or less for 5 days-\$300 each for additional team member(s) over 7. Bundle cost effective package which includes Tier II Days 1, 2, 3, 4, plus half day SWIS Check In/Check Out and additional year of technical support.
