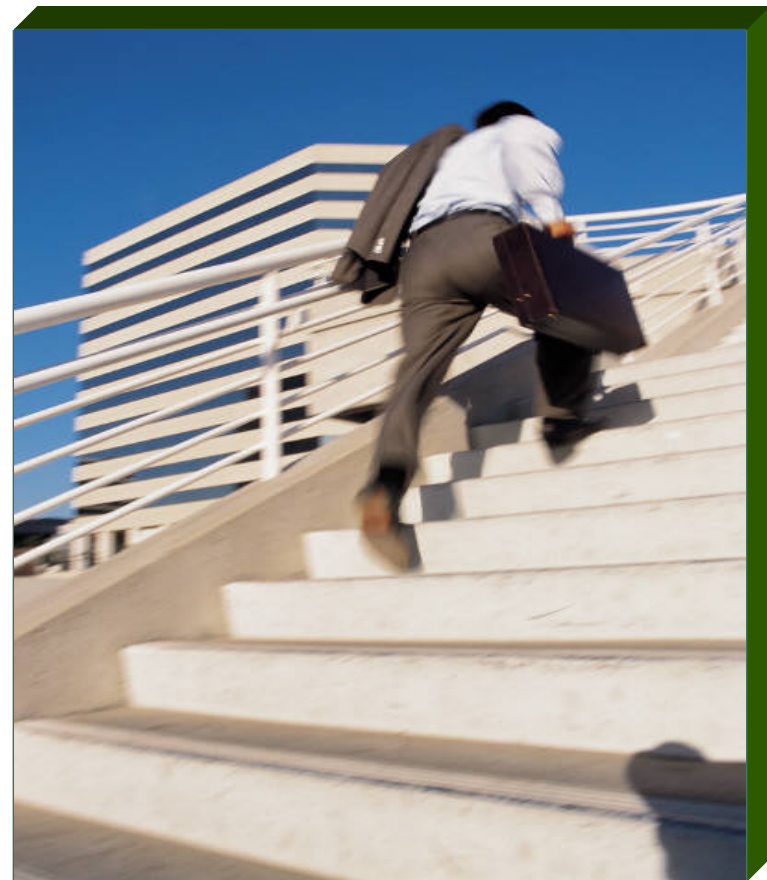

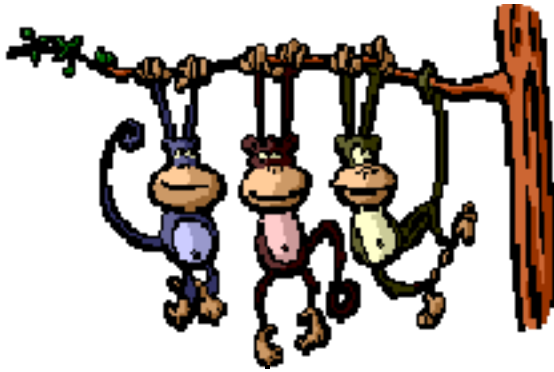


# *What's the Next Step to your PDP Completion?*

Participants will learn the process and procedures to complete the PDP documenting evidence of professional growth and the effect of that growth on student learning. **Participants must bring at least 3-5 pieces of evidence to the workshop along with your PDP. Laptops are recommended.**

***Contents of the workshop include:***

- Overview of procedures for documenting completion of the PDP
- Selecting evidence
- Navigating the change process through evidence of growth
- Articulating the results of growth on student learning
- Describing change related to the professional standards
- Following procedures for labeling and describing evidence
- Completing the summary and reflection
- Ensuring all components are completed
- Possible verification of PDP completion by PDP Team Members
