Technical Workshop Overview:

This seminar will go over the best practices for deploying and managing iPad and iPod Touch in an Education environment.

Education brings special challenges in deploying and managing iPads and iPod Touches, whether the devices are set up in a cart and shared or whether they are deployed in a 1:1 basis. This seminar will demonstrate the best practices for deploying and managing iPads and iPod Touches in both environments and cover topics such as iCloud, device backup, mass deployment, WiFi syncing, and Mobile Device Management servers.

Mobile Device Management (MDM) gives educational institutions the ability to manage large scale deployments of iPhone, iPod Touch and iPad.

These capabilities in iOS give IT departments the ability to securely enroll devices in an enterprise environment, wirelessly configure and update settings, monitor compliance with school policies, and remotely wipe or lock managed devices.

We will also discuss deployment and App Store / Volume Purchase Program best practices, App licensing strategies for both shared devices and personal scenarios. We will also cover best practices for creating and using iTunes store accounts for institutional, personal and layered (both) use of purchased and free Apps.
