**C100: New Coaches Orientation: Nuts & Bolts**

**UTA300: Implementing PBIS in your School, Part 3**

Participants will **revisit** essential school-wide systems (data, teaching, acknowledgement, and interventions) and use the *Team Implementation Checklist (TIC)* to self-assess current implementation and action plans around identified needs. In addition, participants will look at the *Benchmarks of Quality (BOQ)* to begin to understand the use of the tool in self-evaluation.

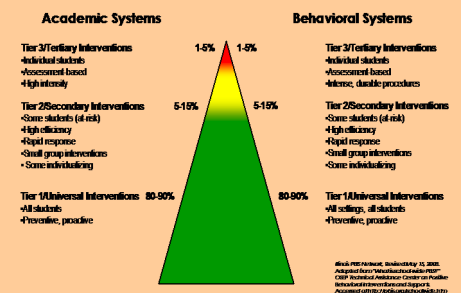
