# Trauma and Loss in Children School Protocol and Response Team Updates

**Trauma and loss knows no boundaries. Debriefing is the process of putting the incident (trauma) and the individual(s) reactions in perspective.**



This workshop is designed to enhance the experience of school crisis team members serving in their role on school crisis response teams. Intervention consists of individual, group, and family participation; educational presentations; and debriefing and defusing trauma with victims, caretakers, teachers and crisis team members. Learn the differences between grief and trauma and how to identify trauma-specific reactions.

Trauma Response Teams, policies, procedures, interventions and postvention strategies are presented for violent and non-violent yet traumatic incidents involving students and/or staff. The workshop will address the potentially suicidal student, completed suicide, responses following any violent or non-violent death, legal liability issues, protocol for dealing with environmental safety and security, and more.

Learn to identify protocols for dealing with potentially dangerous adults/staff/students fighting, students with weapons, shooting in progress, environmental safety and security as well as how to identify the potentially dangerous individual.
