Description

The Department of Public Instruction (DPI) has reviewed the current technology planning requirements and the current format for Tech plan submission. All future Technology Plans from school districts MUST be created in the NEW DPI google template. NO paper technology plans will be accepted. This Technology Planning Workshop is designed to allow districts teams concentrated time to work on the new DPI required format. A representative from the Department will join the session virtually to introduce the new template and requirements and to answer questions throughout the day. You will need a Google account to access the template for the workshop.

Workshop Objectives

- Review scientifically-based research and best practices for information and technology literacy.
- Analyze their current library media and technology plan or combined plans in regard to its support of classroom learning, student achievement and professional proficiency in the area of information processing and technology literacy, integration of ITL standards within the context of content curriculum and ongoing, systematic professional development.
- Utilize the planning model to clarify where they are and where they need to go in the planning process.
- Design an action plan for developing their plan.
- Share sample exemplary plan sections and district planning ideas with workshop participants. The major plan content areas are: Research; Mission/Vision; Data/Needs Analysis; Goals, Objectives, Action Plans; 3-year Budget; Dissemination and Monitoring; School Board Policies

What data should I bring to the workshop?

- An electronic copy of your previous Information and Technology Plan,
- Relevant needs assessment data,
- Your district ESEA goals,
- Your school district vision and priorities for curriculum and professional development, and
- Any other information you think might be useful.
