- 2. Needs Assessment Data
- 3. Implementation Plan (Goals, Objectives, Costs, etc)
- 4. Budget
- 5. Policies
- 6. Progress

#### What data should I bring to the workshop?

Your team should bring a laptop with wireless Internet capability, electronic copy of your previous Information and Technology Plan, relevant needs assessment data, your ESEA goals, school district vision and priorities for curriculum and professional development, budget plan, and any other information you think might be useful.
