Description

S100: This session will help teams establish a seamless system of support from Tier 1 Universal to Tier 2 Secondary Levels of Intervention. Each team will use their Tier 1 Universal data to target groups of students in need of Tier 2 Secondary Levels of Support. Teams will investigate a continuum of Tier 2 Secondary Interventions for students at-risk for behavior or academic failure, who are not responding to Tier 1 Universal Interventions. Teams will begin their Tier 2 Secondary Systems, Data and Practices with the development of the Check- In- Check- Out intervention for their school.

S200: This session will review and problem solve around their school implementation of CICO and then continue to create a continuum of simple Tier 2 Secondary Interventions. Participants will focus on how to implement, Social/ Academic Instruction Groups and examine Mentoring.

S300: This session will focus on increasing the capacity of school staff to evaluate the function of behavior prior to beginning a behavior intervention plan. Tools/format will be shared that will allow for completing a Brief FBA in an efficient and effective manner, so that your school's problem-solving team has the necessary information for planning interventions. Additionally gated screening will be introduced.

S400: Participants will be provided with information about behavior intervention planning that includes developing a Behavior Intervention Plan based upon the Brief FBA they completed. This day will look at how to match intensive social skills instruction, to the function of behavior and addresses the setting events and triggers of the behavior, as well as the maintaining consequences. Systems to support this work will be evaluated/ revised to allow for sustainability. The effectiveness of interventions will be discussed, at both the systems level and the individual student level.

PREREQUISITE: PBIS Tier 2 School Readiness Checklist must be completed and approved by Regional TAC prior to registering for this series including:

- * Team attendance at Universal Training, Days 1, 2 & 3;
- * Administrative attendance at the Tier 2/3 Overview
- * Fidelity on either the Benchmarks of Quality (BoQ) or the Self-Assessment Survey (SAS) from PBIS assessments,
- * School ODR data that documents their Universal interventions are reaching 70-80% of their school students .
- * An identified External Coach for their Tier 2 team
