The Wisconsin Statewide Parent-Educator Initiative (WSPEI) offers a core group of trainings for all district-identified Family Engagement Liaisons. Trainings are offered in two day-long workshops.

These trainings are grant-funded and are FREE to all registered participants!

Day 1-January 29, 2013

- **WSPEI Overview**-review of WSPEI grant history, grant goals and focus of work
- **WSPEI Data System**-review data system with new District Family Engagement Liaisons so that they become familiar with the system and the different types of information collected
- **Confidentiality**-review of confidentiality laws, disclosure, policies and requirements
- **Unauthorized Practice of Law**-raise awareness regarding the significance of the unauthorized practice (UPL) among non-attorney parent/family support persons
- **Effective Communication and Parent-Professional Partnerships**-identify and understand different communication concepts and the process for building relationships with school staff
- **Navigating the Special Education Maze**-understand basic information about special education and learn about resources and tools

WSPEI Family Engagement Liaisons should arrive at 8:30 for specific WSPEI training

(WSPEI overview and WSPEI data system are covered in the morning and designed for district liaisons)

Day 2-March 19, 2013

- **IEP Process and Product**-Review the referral process, timelines, evaluation, and determination of disability and services. Learn about the components of an IEP, the who, what, why and how if IEP's. Parent involvement and parent rights are covered as well.
- **Transition Planning for Students and Families**-Review effective transition requirements and best practices in transition planning, learn about self-determination, and become aware of transition resources and websites. The importance of family engagement in post-secondary planning will be stressed.
