About the Presenter: *Micro Lessons in Writing* and *Writing Circles* are the latest innovations in Jim Vopat’s career-long pursuit of powerful writing instruction and collaboration. At the core of Jim’s work are his beliefs that every student is a writer, and that ever teacher is a teacher of writing. To this end, he founded and currently co-directs the Milwaukee Writing Project. Jim’s other publications include influential essays about writing and parent-family partnerships, a series of parent-leadership video tapes, and *What Makes Writing Good*, *The Parent Project*, and *More than Bake Sales*. Jim has been a senior Fulbright Scholar to Sri Lanka and earned his Ph.D. from the University of Washington-Seattle.
