Description

- AIMSweb is a complete web-based solution for universal screening, progress monitoring, and data management for Grades K-12. AIMSweb provides guidance to administrators and teachers based on accurate, continuous, and direct student assessment.
- This training is for school staff that have purchased AIMSweb academic progress monitoring and data management software. Staff will be asked to log in to their school accounts during training.

This Two Day Training will cover the following:

- clarify the roles AIMSweb data and reporting play in supporting Universal Screening and Progress Monitoring within a tiered service model,
- train participants in how to properly administer and score assessments,
- provide research-recommendations for the frequency and duration with which progress monitor data should be collected,
- how to conduct Survey Level Assessment (SLA) and use this information to determine students' present levels of educational performance and help identify the extent to which student demonstrates any achievement gap compared to peers and grade-level expectations,
- how to use data and trend lines to inform decisions regarding when to continue—or change—a student's instructional program,
- how to determine Rate of Improvement, an important factor for determining student progress for SLD identification.

Audience

- School psychologists, special educators, and other professionals responsible for collecting student screening and progress monitoring data.
