New Legislation: Protecting Children in the 21st Century Act

Its aim is to promote safe Internet use by children and to enhance enforcement of child pornography laws. Specifically, Section 215 imposes an additional CIPA requirement for E-rate applicants' Internet Safety Policies. Such policies must include ...educating minors about appropriate online behavior, including interacting with other individuals on social networking websites and in chat rooms and cyberbullying awareness and response.

The **Protecting Children in the 21st Century Act** was recently adopted which now requires that schools "educate minors about appropriate online behavior, including interacting with other individuals on social networking websites and in chat rooms and on cyberbullying awareness and response". This workshop will provide information and resources to equip any educator with the tools necessary to teach "internet safety" to their classroom. The workshop will highlight NetSmartz resources and classroom activities created and produced by the National Center for Missing & Exploited Children[®] (NCMEC) and Boys & Girls Clubs of America (BGCA) for children aged 5 to 17.

The goal of the NetSmartz Workshop is to extend the safety awareness of children to prevent victimization and increase self-confidence whenever they go online. These goals include how to:

- enhance the ability of children to recognize dangers on the Internet
- enhance the ability of children to understand that people they first "meet" on the Internet should never be considered their friend
- encourage children to report victimization to a trusted adult
- support and enhance community education efforts
- increase communication between adults and children about online safety

Participants will receive a copy of the internet safety presentations that can be used for instruction with students, parents or the general community.

The workshop will also include instruction on social networking websites. Participants will be able to experience and explore the world of Twitter, MySpace and Facebook. Additional internet safety resources will also be provided.
