Dr. Louisa C. Moats has been a teacher, psychologist, researcher, graduate school faculty member, and author of many influential scientific journal articles, books, and policy papers on the topics of reading, spelling, language, and teacher preparation. She began her professional career as a neuropsychology technician and teacher of students with learning disabilities. She earned her Master's degree at Peabody College of Vanderbilt and her doctorate in Reading and Human Development from the Harvard Graduate School of Education.

Dr. Moats is the author of one of the nation's best professional development programs for reading instruction, *LETRS*, as well as a number of influential books including *Speech to Print: Language Essentials for Teachers* (Brookes Publishing); *Spelling: Development, Disability, and* 

Instruction (York Press); Straight Talk About Reading (with Susan Hall, Contemporary Books), and Basic Facts About Dyslexia (with Karen Dakin, International Dyslexia Association). She is well known for authoring the American Federation of Teachers' "Teaching Reading is Rocket Science."

## <u>Afternoon Session:</u> Practical Implications for Implementing Evidence-based Practices as Required by Wisconsin's New SLD Rule

This session will focus on the use of evidence-based instructional practices and interventions, which will impact general education and special education in the implementation of Wisconsin's new rule on Specific Learning Disabilities [SLD], which is required as of December 1, 2013. Wisconsin's new rule for the identification of students with specific learning disabilities requires documentation of the effectiveness of primary and supplemental instruction and intervention.
